Graceful Hearts

The CDPHE licenses Graceful heart as an assisted living residence. The residence can't be both an assisted living residence and a behavioral health facility at the same time. Paxton H. from the CDPHE filed a complaint on our behalf sometime between 2/10/25 and 2/20/25. A response to the complaint will be available on the CDPHE website, timing unknown. Kevin will relay this information to Russ Fullmer and other neighbors.

7:18 Treasurer's Report

Delinquent Dues

There is a process by which, during a home sale transaction, we would notify the appropriate party of the amount of outstanding dues, and then we would receive a check for that amount.

Jim believes there is a \$100 late fee per year; he will confirm at next meeting.

Jim shared a form letter that will be sent to homeowners regarding dues and payment via Cheddar Up. The form letter will be sent as an attachment to the newsletter. Dues collection starts 4/1/25.

General discussion over asking for dues without proper enforcement. There was a question about paying an attorney to update the bylaws; this was previously done in 2019.

Fences and Board / Architectural Review

The topic of homeowners putting up fences without Board / Architectural review and approval was discussed; there are questions about parameters and enforceability.

Reserve Fund

The wording of our bylaws with respect to reserves was discussed. The language states that our reserve funding cannot/should not exceed \$20K. Currently, our reserves are around \$15K and our operating costs/balance is around \$5K. There is no issue with increasing our reserves closer to \$20K.

Other Discussion Topics

From the previous meeting's minutes discussion: Let reserves rise to the \$20K limit.

Is there anything we should spend money on?

- Should the Board pursue a grant program? No.
- Should the Board fund neighborhood improvements (e.g. the strip of land 3-4' between residents' fences and the sidewalk along Orchard? Maybe, to be considered/discussed further
- Tait will look into the costs of a large neighborhood map for use at meetings.

7:30 Block Parties

The idea of inviting residents to four or five block parties in cul-de-sacs around the neighborhood was discussed with the intent of building community.

These will be up to the Block Reps to coordinate. A Saturday or Sunday afternoon in June/July is recommended. The HOA will put \$200-250 towards each party.

Jim and Leslie will work on a proposal and have more information at the next meeting.
